NOTICE OF A COMPETITIVE EXAMINATION FIRE TRAINING & SAFETY OFFICER

A written examination will be given within approximately ninety (90) days, on a competitive basis to approved applicants for the purpose of placing names on the competitive employment list for the class of Fire Training & Safety Officer in accordance with the provisions of the Municipal Fire and Police Civil Service Law and the rules of the St. Tammany Fire District No. 4 Civil Service Board.

Application forms may be obtained from Victoria Kinchen, the Secretary to the Civil Service Board, at the Administration Building located at 709 Girod Street, Mandeville, LA, or at <http://my.mandevillefire.com>.

Completed applications and the required attachments must be received by Victoria Kinchen at vkichen@mandevillefire.com or at 709 Girod Street, Mandeville, LA by Friday, August 26, 2022 at 4:01 P.M. Approved applicants will be notified of the exact date, time, and place of the examination at least five (5) days prior to the examination.

QUALIFICATION REQUIREMENTS: Unless otherwise specified, all requirements listed below must be met by the filing deadline for application for admission to the examination.

- Must meet all requirements of the Municipal Fire and Police Civil Service Law, including being a citizen of the United States and of legal age.
- After offer of employment, but before beginning work in this class, must pass a physical examination, the selection and administration of which shall be authorized by the Appointing Authority, designed to demonstrate good health and physical fitness sufficient to perform the essential duties of the position, with or without accommodation.
- Applicant must possess one of the following: high school diploma, high school equivalency certificate, high school transcript, affidavit from the issuing high school, associate's or bachelor's degree, or college transcript, any one of which must indicate that graduation has occurred or a degree awarded. A certification of completion shall not be sufficient to substitute for a diploma or equivalency certificate.
- Must possess a valid driver's license.
- Must have at least three (3) years full time experience in fire suppression with a paid fire department.
- Must possess IFSAC certification as Firefighter II.
- Must possess IFSAC certification as Fire Service Instructor II.
- Must possess certification as a Nationally Registered EMT-Paramedic.

APPLICANT: To be considered for admission to this examination you must attach a copy of the following documents to your application before you submit your application to this civil service board.

- Birth Certificate verifying United States Citizenship (or citizenship documentation).
- Valid driver's license.
- Firefighter II Certification.
- Fire Service Instructor II Certification.
- National Registered EMT-Paramedic Certification.
- High school diploma, high school equivalency certificate, high school transcript, affidavit from the issuing high school, associate's or bachelor's degree, or college transcript, any one of which must indicate that graduation has occurred or a degree awarded. A certification of completion shall not be sufficient to substitute for a diploma or equivalency certificate.
