SAMPLE BALLOT

Residents of Fire District #4 will be asked to vote on the following propositions pertaining to the Mandeville Fire Department's millage renewals and parcel fee. The existing millage renewals referenced in Propositions 1 & 2 currently fund all emergency services in District #4. The parcel fee referenced in Proposition 3 will fund the building, equipping and staffing of two additional fire stations in District #4, which will improve emergency response times and minimize risk to life and property.

PROPOSITION NO. 1 (TAX RENEWAL)

Shall St. Tammany Fire Protection District No. 4, State of Louisiana (the "District") renew the levy of a special tax of twenty-five (25) mills on all property subject to taxation in the District (an estimated \$13,794,041.50 reasonably expected at this time to be collected from the levy of the tax for an entire year) for a period of twenty (20) years, commencing with the year 2022 and ending with the year 2041, for the purpose of acquiring, constructing, improving, maintaining and/or operating fire protection facilities and equipment for the District, including the cost of obtaining water for fire protection purposes, and providing emergency medical response and transportation service in the District?

PROPOSITION NO. 2 (TAX RENEWAL)

Shall St. Tammany Fire Protection District No. 4, State of Louisiana (the "District") renew the levy of a special tax of one (1) mill on all property subject to taxation in the District (an estimated \$551,761.66 reasonably expected at this time to be collected from the levy of the tax for an entire year), for a period of twenty (20) years, commencing with the year 2022 and ending with the year 2041, for the purpose of acquiring, constructing, improving, maintaining and/or operating fire protection facilities and equipment for the District, including the cost of obtaining water for fire protection purposes, and providing emergency medical response and transportation service in the District?

PROPOSITION NO. 3 (PARCEL FEE)

Shall St. Tammany Fire Protection District No. 4, State of Louisiana (the "District") be authorized to levy and collect a parcel fee of \$75.00 per year on each lot, subdivided portion of ground or individual tract upon which is located, either in whole or in part, a residential or commercial structure, regardless of whether the structure is being occupied or unoccupied, within the District, for a period of 23 years, commencing with the year 2019 and ending with the year 2041 (an estimated \$1,500,00.00 reasonably expected to be collected from the levy of the parcel fee for an entire year) with the avails or proceeds of said parcel fee to be used entirely and exclusively for the acquisition, construction, maintenance and operation of fire protection facilities and equipment, including the costs of obtaining water for fire protection purposes and salaries of firemen, and all purposes incidental thereto, within the District?
